

Application for a new specific purpose water access licence (SPAL)

This is an application for minister's approval for a new specific purpose water access licence (SPAL) under section 61 (1) (a) of the Water Management Act 2000.

There are only certain circumstances on where an access licence can be issued for a specific purpose, these are declared in the <u>Water Management (General) Regulation Act 2018</u> under section 5.

A SPAL specifies the purpose it can be used for and may limit the operation of the SPAL to a particular location where it can be used. A SPAL will be cancelled if the purpose for which it was granted no longer exists.

What you need to do

Applicants are advised to read the instructions carefully before filling in this form. Step-by-step instructions on each section are included in the <u>guide</u> to the "Application for a new specific purpose water access licence (SPAL)".

Please complete the form with a black/blue ink pen and use BLOCK letters. You can also type directly in this form. Once completed, please print and sign the form.

If a water access licence is granted, the *Water Management Act 2000* requires that various details relating to the water access licence are to be recorded in the Water Access Licence Register kept by the Minister. Information recorded in the Water Access Licence Register is publicly available.

Offence and suspension or cancellation

It is an offence, under section 344 of the *Water Management Act* 2000, to make a statement that you know to be false or misleading in, or in connection with, this application.

A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500. An access licence or approval may be suspended or cancelled under the *Water Management Act 2000* in certain circumstances. These include if the holder of the licence or approval is convicted of an offence under that Act.
