#### Submit your application form

Submit your completed application (including the state of origin form) to the **agency administering the interstate water licence**. The relevant agency in the state of origin will forward the application (including this form) to WaterNSW if it is accepted. The application will be delayed if it is incomplete or incorrect, as further information will be requested. If this information is not received within the specified time, WaterNSW will reject the application.

The relevant agency in the state of origin will forward a copy of the whole application (including this form) once it is accepted.

If an approval is granted, the *Water Management Act 2000* requires that various details relating to the approval are to be recorded in the Register of Water Approvals kept by the Minister. Information recorded in the register is publicly available.

#### Offences and penalties

It is an offence, under section 344 of the *Water Management Act 2000*, to make a statement that you know to be false or misleading in, or in connection with, this application.

A corporation found guilty of an offence against section 344 is liable to a penalty not exceeding \$2.002 million. An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500. An access licence or approval may be suspended or cancelled under the *Water Management Act 2000* in certain circumstances. These include if the holder of the licence or approval is convicted of an offence under that Act.

# Application to tag an interstate water licence to a NSW approval (extraction point)



This guide is provided to assist you in completing the Application to tag an interstate water licence to a NSW approval (extraction point).

#### **General instructions**

To make sure that your application is processed efficiently, please note these general instructions:

- Ensure that you fully complete the form, as all the information is necessary to verify and process your application.
- Include the appropriate fee with your application. A schedule of fees is available at waternsw.com.au/applications



The application will be delayed if it is incomplete or incorrect. WaterNSW will notify you of any delay or if further information is required. If this information is not received within the specified time, WaterNSW will reject the application.

#### **Submitting your application**

Submit your completed application (including the State of origin form) to the agency administering the interstate water licence. The relevant agency in the state of origin will forward the application (including this form) to WaterNSW if it is accepted.

## Section A: Interstate water entitlement – State of origin.

**A1-2** Insert the number of the water share (Victoria) or the entitlement (South Australia).

You will need to obtain and complete the state of origin form required by the relevant interstate agency. The state of origin form comprises an integral component of your application. Failure to attach the completed state of origin form will invalidate this application.

### Section B: NSW approval (extraction point) – State of destination

This section is used to specify the nominated work (NSW extraction point) to which the interstate entitlement specified in A1 is to be 'tagged'.

**B1** Enter the NSW approval number. The approval must either be a water supply work approval or a combined water supply work and water use approval.

#### **Section C: Nominated contact**

These are the contact details of either the applicant or the applicant's representative. All correspondence related to this application will be sent to the contact person.

#### Section D: Declaration of WAL holders

Please ensure you understand your legal obligations before signing this document.

If you require assistance, please contact your local WaterNSW Office.

- **D1** Each of the approval holders must fill in their name, followed by a signature and the date of signing.
- **D2** If the holder is a company, insert the name of the company.
- **D3** Insert the name of the company signatory/representative.
- **D4** Insert the title or position of the company's signatory/representative.
- **D5** An independent witness is required to sign this section in order to verify that the position stated in D3 above, is the position held by the signatory in D4.
